### COUNCIL CIRCLE MEMBERSHIP

Minimum Annual Commitment: **\$500**

Teach NYS Council Circle members understand the importance of lobbying the New York legislature on additional funding so all children will be safe and have a competitive edge when they enter the workforce. Members will receive annual benefits including invitations to exclusive events in their area, nation-wide conference calls with leading experts in the field of Education Policy, and invitations to respond to Action Alerts. Council Circle members are also able to participate in the Teach NYS Network Program, where we match elected officials with community members to cultivate relationships throughout the year.

### ASSEMBLY CIRCLE MEMBERSHIP

Minimum Annual Commitment: **\$1,800**

In addition to the benefits of Council Circle membership, Assembly Circle members will receive annual benefits including invitations to exclusive happenings in their area, special Assembly Circle-only events, and receive two tickets to our Annual Legislative Breakfast and four tickets to our Annual Mission to Albany.

### SENATE CIRCLE MEMBERSHIP

Minimum Annual Commitment: **\$5,000**

In addition to the benefits of Assembly Circle membership, Senate Circle Members will be expected to engage in political activity in New York. Senate Circle members will receive annual benefits including invitations to special Senate Circle events, receive four tickets to our Annual Legislative Breakfast and six tickets to our Annual Mission to Albany, and receive exclusive invitations to meet and greets with elected officials throughout the year.

### GOVERNOR CIRCLE MEMBERSHIP

Minimum Annual Commitment: **\$10,000**

In addition to the benefits of Senate Circle membership, Governor Circle Members will receive annual benefits including invitations to exclusive Governor Circle events in their area, receive a table of ten seats at our Annual Legislative Breakfast, six tickets to our Annual Mission to Albany, and two tickets to our annual Mission to D.C.
